The Transaction

Signing and closing took place on August 1, 2017 and Intrinsys will be consolidated as part of Addnode Group's Product Lifecycle Management Division. The initial purchase price for all shares in Intrinsys amounts to SEK 119 million, subject to an adjustment based on the actual level of net cash and net working

capital in Intrinsys at July 31, 2017. The acquisition was paid in cash on completion. In addition a capped conditional purchase price of SEK 43 million is payable if certain targets are achieved linked to Intrinsys operating profit during 2017 and 2018. The acquisition is financed through Addnode Group's existing credit facilities and is expected to have a positive impact on Addnode Group's earnings per share. The transaction was not subject to any conditions for completion to occur.
